The Corporation is authorized to issue One Thousand (1,000) Shares. par value One Dollar (\$1.00) per share. The aggregate par value of the Common Shares is One Thousand Dollars (\$1,000).

If the shareholders vote authorizing the issue of new shares shall so provide, or if the shares are offered for subscription to holders of common shares, and at the expiration of the subscription period any of the shares remain unsubscribed for, then the shares may be issued and sold at any time or from time to time on any terms or conditions, and to such persons, as the board of directors may determine. The shareholders may, when voting to authorize issuance of new shares, waive the rights created by this provision, and the waiver will be binding on all the shareholders of the Corporation.
