WE, THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATION, NATURAL PERSONS, COMPETENT TO CONTRACT, OF LEGAL AGE, BY THESE PRESENT HEREBY FORM A CORPORATION UNDER THE LAWS OF FLORIDA.

ARTICLE I

**THE NAME OF THIS CORPORATION SHALL BE:
PROFESSIONAL GROUP ASSOCIATES INC.**

ARTICLE II

THIS CORPORATION SHALL HAVE PERPETUAL EXISTANCE, COMMENCING UPON THE FILING OF THESE ARTICLES OF INCORPORATION WITH THE DEPARTMENT OF STATE, STATE OF FLORIDA.

ARTICLE III

PURPOSE AND POWER.

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF ENGAGING IN ALL LAWFULL BUSINESS PERMITTED TO A CORPORATION ORGANIZED UNDER THE FLORIDA GENERAL CORPORATION LAW AND SHALL HAVE ALL THE POWER SET FORTH IN SAID LAW.

ARTICLE IV

CAPITAL STOCK

THE AMOUNT OF CAPITAL STOCK SHALL CONSIST OF ONE HUNDRED (100) SHARES OF COMMON STOCK WITH \$10.00 DOLLARS PAR VALUE (EACH SHARES).

THE CAPITAL STOCK OF THE CORPORATION MAY AT ANY TIME BE INCREASED OR DECREASED AS PROVIDED BY THE LAWS OF FLORIDA. THE HOLDERS OF THE OUTSTANDING CAPITAL STOCK SHALL BE ENTITLED TO RECEIVE, WHEN AND AS DECLARED BY THE BOARD OF DIRECTORS, DIVIDENDS PAYABLE EITHER IN CASH OR IN PROPERTY SOLELY OUT OF THE UNRESERVED AND UNRESTRICTED EARNED SURPLUS OF THE CORPORATION AND DIVIDENDS PAYABLE IN SHARES OF CAPITAL STOCK, AS PROVIDED BY THE FLORIDA LAW.

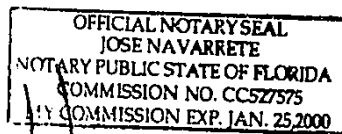

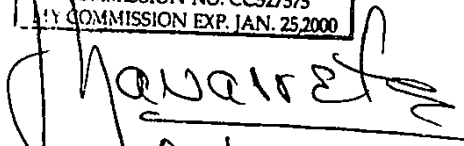

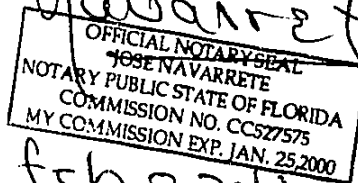
