ARTICLE I - NAME

The name of this corporation is L & C INDUSTRIES, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".
