I (WE) the undersigned, do to hereby associate ourselves together and subscribe this certificate of incorporation for the purpose of forming, a corporation under the laws of the State Of Florida, and subject to the following.

**Provisions:**

**\*\*\*\*\*ARTICLE ONE\*\*\*\*\***

The name of the corporation shall be :

**\*\*\*\*\*ARTICLE TWO\*\*\*\*\***

The corporation may engage in any activity or business permitted under the laws of the United States Of America and of the State Of Florida.

\*\*\*\*\*ARTICLE THREE\*\*\*\*\*

The maximum number of shares of stock which the corporation shall have outstanding at any time, shall three hundred (300) shares of stock which shall be common stock of a par value of One hundred(\$100.00) dollars per share, all or any part of the capital stock may be paid for either in lawful monies of the United States Of America, or in services, at a true value thereof.



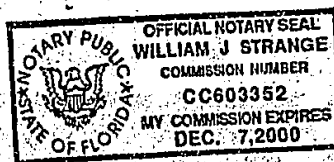
