ARTICLES OF INCORPORATION
OF
ALPHA TOURS & TRANSPORTATION, INC.

ARTICLE I - NAME

The name of this Corporation is ALPHA TOURS & TRANSPORTATION, INC., initial address: 5538 Suncreek Court, Orlando, Florida 32839.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on February 18, 1997.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK


