ARTICLES OF INCORPORATION

TO THE SECRETARY OF THE STATE OF FLORIDA;

We the undersigned of whom are over the age of eighteen years, desiring to become a body corporate under and pursuant to the laws of the State of Florida, for the purpose hereinafter stated and set forth, do hereby file in the office of the Secretary of State of said State this Certificate of Incorporation, in accordance with the laws of the State of Florida, and we do hereby set forth and certify as follows.

ARTICLE I

The name of the corporation shall be:

ROYAL PRECISION MACHINE, INC.

ARTICLE II

The objects and purposes for which this corporation is formed are as follows:

1. To engage in a business enterprise specializing in metal fabrication and a general machine shop.

2. To generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform.

3. To purchase, lease, exchange, or otherwise acquire real and personal property of all kinds, character and description, whether improved or unimproved and any interest therein; to own, hold, control, maintain, improve, rebuild, enlarge, alter, manage, operate and control office building or buildings for the use by the company on lands owned or held by the corporation; to lease or sublet, mortgage, exchange, assign, transfer, convey, pledge or otherwise alienate or dispose of any of such real and personal property and any interest therein.

4. To purchase, or otherwise acquire, hold, exchange, pledge, hypothecate, seli, deal in and dispose of mortgages, liens, or other encumbrances covering any kind, character or description of real or personal property; to loan money secured by mortgages on real estate.

5 To purchase or otherwise acquire hold cell evenance pladae

6. To make loans or money, secured or unsecured, by endorsement or other collateral as may be permitted by law governing the conduct of a corporation.

7. To borrow or raise monies for any of the purposes of the corporation and from time to time to make, accept, endorse, execute and issue promissory notes, drafts, evidences of indebtedness and agreements; to secure the payment thereof by mortgage, pledge, conveyance or assignment in trust, of the whole or any part of the asets of the corporation, whether at the time owned or therafter acquired; and to seil, pledge, or otherwise dispose of such securities or other obligations of the corporation for its corporate purposes.

8. To enter into and make all necessary contracts and agreements for its business with any person, partnership, association or corporation or of any domestic or foreign state, government or governmental authority or any political or administrative subdivision or department thereof and to perform and carry out, assign, cancel or rescind any such contracts.

ARTICLE III

The Corporation shall have perpetual existance.

ARTICLE IV
