The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

**ARTICLE I: NAME AND MAILING ADDRESS**

The name of the corporation is WORLDWIDE CONTRACTING, INC., the address of the principal office of this corporation shall be 612 S. Federal Highway, Stuart, Florida 34994 and the mailing address of the corporation shall be the same.

**ARTICLE II: NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation.

**ARTICLE III: CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock having a par value of One (\$1.00) Dollar per share.

**ARTICLE IV: REGISTERED AGENT AND OFFICE**
