ARTICLES OF INCORPORATION OF TOP TEN SOUNDS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Top Ten Sounds, Inc.,

ARTICLE II. PRINCIPAL OFFICE

The principal place of business address and mailing address of this corporation shall be 10060 Griffin Road, Cooper City, Florida 33328.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100,000 shares of common stock having a par value of \$.01 (one/hundredth of a dollar).
