ARTICLES OF INCORPORATION OF HODGES CAR WASH, INC.

The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Excicles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation is: Hodges Car Wash, Inc.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this corporation, which is also the mailing address of the corporation, is 1800 The Greens Way, #1008, Jacksonville Beach, FL 32250.

ARTICLE III. DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE IV. PURPOSES
