

ARTICLE I - Name

The name of the corporation is: Barbara P. Srur, M.D., P.A.

ARTICLE II - Existence

This corporation shall commence existence on receipt and filing of these articles.

ARTICLE III - Purpose

The general purpose for which this corporation is organized shall be the transacting of any or all lawful medical practice for which corporations may be incorporated under the provisions of Chapter 621, Florida Statutes.

ARTICLE IV - Capital Stock

This corporation is authorized to issue 1,000 shares of common stock, each having a par value of \$ 1.00. The stock will be classified as 1244 stock for Internal Revenue purposes.

ARTICLE V - Initial Registered Office and Agent

ARTICLE VIII - Incorporator



ARTICLE X - Indemnification

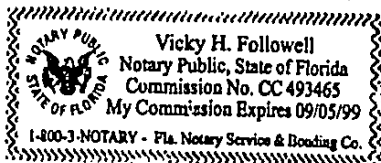


