ARTICLES OF INCORPORATION

OF

TANGO M, INC.



ARTICLE I - NAME AND ADDRESS

The name of this corporation is TANGO M, INC. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 2665 South Bayshore Drive, Suite 904, Miami, Florida 33133.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.
