The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is **ONLY QUALITY MEDICAL PROFESSIONALS, INC.**

ARTICLE II

Principal Office

The principal office and mailing address of the corporation shall be 590 East 25th Street Suite 501, Hialeah, Florida 33013.

ARTICLE III

Duration

This corporation shall exist perpetually.
