ARTICLES OF INCORPORATION

OF

RECLAIMED RESOURCES, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be Reclaimed Resources, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be 12311 Eagle Point Circle, Fort Myers, FL 33913, and the mailing address shall be P. O. Box 61008, Fort Myers, FL 33906.

ARTICLE III CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is ONE THOUSAND (1000) SHARES, consisting of one class only designated as "common stock," with no par value.

ARTICLE IV INITIAL REGISTERED AGENT AND ADDRESS
