ARTICLE IV


The initial capital of this corporation shall be in excess of Five Hundred Dollars (\$500.00).

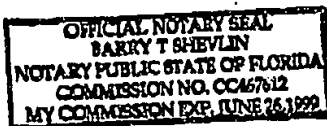


