1. The name of the Corporation is FPD Holdings, Inc.
2. Article I, "NAME," of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE I - NAME

The name of this corporation is STATEWIDE LAUNDRY EQUIPMENT MIAMI, INC., with its principal office and address being located at 5300 N.W. 12th Ave., Bay #7, Fort Lauderdale, FL 33309."

3. The foregoing amendment was adopted by the sole Director and sole Shareholder of the Corporation eligible to vote by a Written Consent signed by him on July 1, 1999, manifesting his intention that this amendment to the Articles of Incorporation be adopted, pursuant to Section 607.1003, Florida Statutes.
