ARTICLES OF INCORPORATION

OF

WAREHOUSE 38, INC.

ARTICLE I

The name of the corporation is WAREHOUSE 38, INC. and its mailing address and principal place of business is 288-Z Smith Sundy Road, Delray Beach, Florida 33446.

ARTICLE II

The corporation shall have perpetual existence.

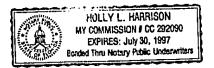
