ARTICLES OF INCORPORATION OF: Personlized Billing Services, Inc.

We, the undersigned, are desirous of forming a corporation under the laws of the State of Florida, such laws that are applicable to corporations for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be Personlized Billing Services, Inc. its principal place of business shall be 7609 Sanibel Cir. S. Tampa, Florida 33637

ARTICLE II

GENERAL NATURE OF BUSINESS

The general purpose or objectives to be transacted, promoted or carried on by this corporation are: Any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

SHARES OF STOCK-NUMBER

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock at the par value of \$.50 per share.

The shares shall carry no pre-emptive rights.

Stock in this corporation shall be paid for in lawful money of the United States of America, or in property, labor or services, provided that where stock is paid for in or by property, labor or services, the just value thereof shall be fixed by the incorporators or the Board of Directors, in the manner prescribed by state statute.

ARTICLE IV

AMOUNT OF CAPITAL

The amount of capital with which the corporation will begin business will be a minimum of \$500.00

ARTICLE V

DURATION

This corporation is to have perpetual existence, commencing upon the approval of these Articles of Incorporation by the Secretary of State.

ARTICLE VI

DIRECTORS



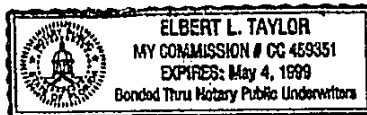
