

ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is ----- JOE KINGSLEY INC.
and whose principal office location is 217 ORANGE TERRACE

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:
