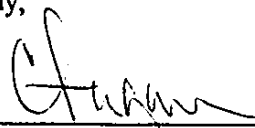

Article I

*Name.* The name of this Corporation is KTO, INC.

**EFFECTIVE DATE**

2-17-97

Article II

*Principal Office.* The address of the principal office of the Corporation is 2531 N.W. 41st St., Bldg. D, Gainesville, FL 32606.

Article III

*Duration.* The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

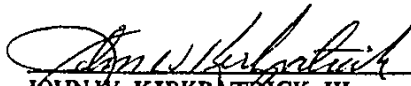

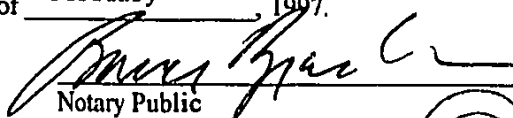

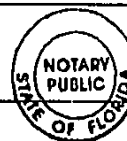
