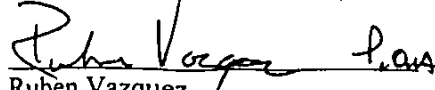
The corporate name shall be changed from Lake Worth Rd. Shell, Inc. to R. Vazquez, Inc.

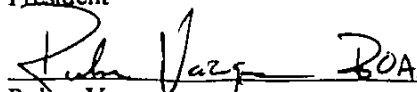
2. The foregoing amendments were adopted by the Stockholders and Directors of the corporation on the 2nd day of April, 1997.:
