ARTICLES OF INCORPORATION

OF

CUSTOM CHARTERS, INC.



The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the Corporation is:

CUSTOM CHARTERS, INC.

The address of the principal office of this Corporation shall be 2520 Constitution Blvd., Sarasota, FL 34231, and the mailing address of the Corporation shall be the same.

ARTICLE 2. DURATION. The duration of the Corporation is perpetual.
