**ARTICLE I
Corporate Name and Address**

**ARTICLE II
Corporate Purposes**

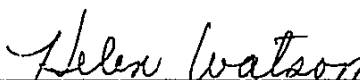

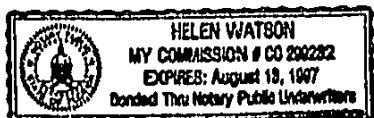
