THE UNDERSIGNED, who desires to form a professional service corporation in accordance with Chapters 621 and 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is Kevin Michael McEvoy, M.D., P.A. Its principal place of business is located at 297 Plantation Hill Road, Gulf Breeze, Florida 32561.

ARTICLE II

PURPOSE

The purpose for which the Corporation is organized is to practice the profession of medicine.

These Articles of Incorporation may be amended in the manner provided by law.




