ARTICLES OF INCORPORATION

OF

GOOSE INDUSTRIES, INC.

ARTICLE I

This corporation will be a Subchapter S corporation by the name of Goose Industries, Inc.

ARTICLE II

The nature of the business is to act to the extent permitted under Florida Statutes, Chapter 607 (1996 as amended), and to engage in every business permitted under the laws of the State of Florida and the United States.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have at any time shall be One Thousand (1,000) shares of common stock of One Dollars (\$1.00) par value per share.

ARTICLE IV

The corporation shall begin business with a capital stock of not less than Five Hundred Dollars (\$500.00).

ARTICLE V

This corporation shall exist perpetually.

ARTICLE VI

The post office address of the initial principal office of this corporation is 303 Sunset Road, West Palm Beach, Fl 33401-7925, and the name and address of the Registered Agent are: John R. Further, the corporation may have such other place of business, both within and without the State of Florida, and in foreign countries as may be necessary or convenient.

The business of this corporation shall be conducted by a board of directors of one or more directors.

#### ARTICLE XII


