## ARTICLES OF INCORPORATION

OF

#### VILLAGE BARBER STYLIST, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

#### **ARTICLE I - NAME & ADDRESS**

The name of this Corporation is VILLAGE BARBER STYLISTS, INC. The principal office, if known, or the mailing address of the Corporation is 3030 East Semoran Boulevard, Suite 128, Apopka, Florida 32703.

#### ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

#### ARTICLE IV - SHARES

The aggregate number of shares which the Corporation is authorized to issue is 1000 shares of common stock. Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.
