The undersigned, for the purpose of forming a corporation for profit under the laws.

The following Articles of Incorporation: of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is CIKA PROPERTY MANAGEMENT, INC.
