Gentlemen:

We have just received from your department a notice of administrative dissolution or revocation for Piertec, Inc., our Florida Corporation.

It comes to us in a peculiar manner. Not only are we very surprised, but it appears that the notice has a pasted handwritten address change placed on the printed envelop. It is furthermore address to me personally, and secondly, it is addressed to my home residence address here in Pennsylvania. this is not normal and certainly strange at best.

The reason I mention this is I spoke with one of your assistants on the matter of the current status of our company, Piertec, Inc. I was advised the company needs to be reinstated for failure to have completed and filed the annual report on or before May 1st., 2000.

I do not disagree that every year we have filed such a report. It is required and has been filed by our company since we started business with Florida.

What I am up-set about is we have not received in the past months the annual report forms from your offices so we might complete the report in a timely manner. Perhaps it is entirely not your fault at all, but might relate to the post office handling of the mail.

I asked your assistant when you mail out the reports. I was advised it is in the month of December applying to the next year...also, the form/report has to be submitted to you on or before May 1st.

Our problem is we never received the report and as a result, we have not filed the report before the May 1st deadline requirement.

It would appear from the report that we have just received, someone in the post office merely placed my name on the report and resent it to Pennsylvania.

No doubt, if I am correct, there appears to be more of a problem with this particular post office on our mail. We have had similar circumstances of not receiving mail in the past. I thought the matter had been taken care of, but with this report and the way it has been received, I must be
