CERTIFICATE OF INCORPORATION

DISTRIBUTORS, M.T.S. DIETRIBUTION, INC.

ARTICLE I - NAME

The name of this corporation shall be M.T.S. DISTRIBUTION, INC.

ARTICLE II - NATURE OF BUSINESS
