ARTICLES OF INCORPORATION

OF

SUWANNEE VALLEY INTERNET CONNECTIONS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE: NAME

The name of the corporation is Suwannee Valley Internet Connections, Inc.

ARTICLE TWO: PRINCIPAL OFFICE
