The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following articles of incorporation:

ARTICLE ONE  
NAME

The name of the corporation is DYNANET, INC. The address of the principal office of this corporation shall be 426 Casey Key Road, Nokomis, Florida 34275 and the mailing address shall be the same.

ARTICLE TWO  
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE  
PURPOSE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR  
CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is 1,500 all of which shall be common shares with a par value of \$1.00 per share.

The name and address of the incorporator is H. Vernon Davids, 165 West Green Street, Englewood, Florida 34223.


