I, the undersigned subscriber to these Articles of Incorporation, am a natural person competent to contract for the purpose of forming a professional corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this professional corporation is: **Jack Bloodgood Architect, P.A.**

**ARTICLE II**

The general nature and purpose of this professional corporation shall be to engage in the general practice of Architecture, Architectural Consulting, Interior Design, Interior Design Consulting, Editorial Writing and Architectural Writing. The professional services involved in this corporation's practice may be rendered only through its officers, agents and employees who are duly authorized and licensed to practice Architecture and registered with the National Council of Architectural Registration Board (NCARB). This professional corporation may also operate a general business and other related business, and to buy, hold, or otherwise acquire, mortgage, sell, convey, lease or otherwise dispose of real and personal property, and to purchase, or otherwise acquire, own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, wares, merchandise, real and personal property and services of every class, kind and description, to contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporate

indebtedness as required, except that it is not to conduct a banking, safe deposit, trust, insurance surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.

### **ARTICLE III**

The aggregate number of shares of stock that this corporation is authorized to issue One Hundred (100) shares of \$1.00 par value common stock.

### **ARTICLE IV**
