

The undersigned, for the purpose of forming a corporation hereby adopt the following Articles of Incorporation.

ARTICLE ONE
NAME

The name of the Corporation is W.P.A., Inc., P.O. Box 22023, Tampa, FL 33622-2023.

ARTICLE TWO
DURATION

The term of existence of the Corporation is perpetual.

PURPOSE




