ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is BEACH STROLLER RENTALS, INC. located at 133 University Circle, Ormond Beach, FL 32176.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
