ARTICLE ONE

Name of Corporation. The name of this corporation shall be Vector Van Transportation, Inc.

ARTICLE TWO

General Nature of Business. This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida for which corporations may be organized under the laws of the State of Florida.

ARTICLE THREE

Authorized Capital Stock. The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time shall be seventy-five hundred (7,500) of common stock with a par value of \$1.00 per share.

ARTICLE FOUR

Preemptive Rights. The corporation elects to have preemptive rights in accordance with §607.0630(2), Fla. Stat. (1989).

Term of Existence. This corporation is to exist perpetually unless dissolved according to law.




