ARTICLES OF INCORPORATION

The undersigned, acting as subscriber of a corporation under the Florida Corporation Law, adopts the following Articles of Incorporation for such corporation:

1.

Name

The name of the corporation is:

Purpose

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

Stock

The maximum number of shares the corporation shall have the authority to issue is SEVEN THOUSAND FIVE HUNDRED (7,500) shares of capital stock with a par value of \$1.00 PER SHARE. ONE THOUSAND (1,000) shares of the capital stock of the corporation shall be issued for cash at a par value of \$1.00 per share as the initial issue.

The amount of capital with which the corporation shall begin business is not less than ONE HUNDRED DOLLARS (\$100.00).

The corporation shall have perpetual existence.
