ARTICLES OF INCORPORATION

of

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles Of Incorporation for such corporation:

- 1. NAME: The name of the corporation is J.M. STEEL ERECTORS, INC.
 - 2. DURATION: The period of its duration is perpetual.
- 3. **PURPOSE:** The purpose of the corporation is to engage in any activities or businesses permitted under the laws of the State of Florida.
- 4. STOCK: The corporation shall have the authority to issue 1,000 shares, all in one class at non par value.
- 5. REGISTERED AGENT: The address of the initial registered office of the corporation is 25 Wildwood Drive, Palm Coast, Florida 32137, and the name of its initial registered agent at said address is JERRY MILLER.
