## PLAN OF LIQUIDATION OF NATIONAL SCOUTING REPORT OF SOUTHWEST FLORIDA, INC.

- c. Proceed to pay and satisfy the Corporation's liabilities and obligations or make adequate provision for payment and discharge thereof, and do all other acts required to liquidate the Corporation's business and affairs.
