ARTICLES OF INCORPORATION

EFFECTIVE DATE OF
BARBEC ENTERPRISES, INC.

The undersigned Incorporator of these Articles of Incorporation is a natural person competent to contract and hereby forms a corporation for profit under the General Corporation Act and other laws of the State of Florida.

ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is BarBec Enterprises, Inc. and its principal office is located at 10405-5 St. Augustine Road, Jacksonville, Florida 32257 with a mailing address at P.O. Box 23647, Jacksonville, Fl 32241-3647.
