1. The name of the corporation filing these Articles of Amendment is Southeast Medical Group, P.A.
2. The text of the amendments to the Articles of Incorporation of Southeast Medical Group, P.A. are as follows:

First Amendment:

The name of the corporation shall be SOMEDICAL, Inc.

This new name shall amend and replace the name "Southeast Medical Group, P.A." so that henceforth the name of this corporation shall be SOMEDICAL, Inc.

Second Amendment:

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

This new business purpose shall have the effect of converting this corporation from a professional service corporation under Chapter 621, Florida Statutes, to a general business corporation under Chapter 607, Florida Statutes.

3. The foregoing amendment was adopted by the corporation on August 31, 1998, to be effective on the date of the filing of these Articles of Amendment with the Secretary of State.

4. The foregoing amendment was based on the unanimous consent of the shareholders of the corporation.
