

I received your letter dated December 28, 2000, but not postmarked until January 2, 2001. Your letter indicated that your office was unable to waive the reinstatement fee, unless our corporation never received prior notification from your office.

Our company did not receive prior notification by mail prior to the Notice of Administrative Dissolution or Revocation. Perhaps it was because we had been Administratively Dissolved in 1999; maybe it was for some other reason that the notification didn't reach us.
