ARTICLE ONE

The name of the corporation is **THE ROJAS FAMILY, INC.** The principal address of the corporation is: 1151 Sorrento Drive, Weston, Florida 33326.

The period of its duration is perpetual.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
