As accountants for Alten Limited Partnership and its general partner, Megalodon, Inc. (DOC # P97000020844), we are responding to your letter # 303A00017146 dated March 20, 2003. The purpose of your letter was to return the 2003 Uniform Business Report (UBR) for Alten Limited Partnership since the general partner, Megalodon, Inc., was administratively dissolved. The original fee of \$141.25 was not returned with your letter.

Attached are the following documents and fees necessary to bring both entities current through 2003. Please process the following forms accordingly.


