

ARTICLE ONE

The name of the corporation is **FONE-FUN, INC.** The principal address of the corporation is: 8400 N.W. 21 Court, Sunrise, Florida 33322.

The aggregate number of shares which the corporation shall have authority to issue is one **hundred (100)** of **no par value**.


ARTICLE FIVE
