

ARTICLES OF INCORPORATION

The undersigned, desiring to organize a corporation under Chapter 607, Florida Statutes, sets forth the following:

#### ARTICLE I

The name of the corporation shall be M. C. Floyd Building Contractor, Inc.. The address of the principal office of the corporation and the mailing address of the corporation is 1899 Oak Trail, Callahan, Florida 32011.

#### ARTICLE II

The duration of the corporation shall be perpetual.

#### ARTICLE III

The general nature of business or businesses to be transacted by this corporation is as follows:

- (a) This corporation may engage in any activity or business permitted under the laws of the United States and of this state, for profit.
  - (b) Building contractor.
- 2. The purposes enumerated herein are intended as illustrative and non-restrictive; this corporation shall have the power to handle such other business or businesses, either in its own behalf or as agent or broker for others, and shall further engage in any and all businesses which may be considered profitable, and all for profit; and, generally, this corporation shall have and exercise all powers, privileges and immunities

given to incorporators and to corporations under the laws of the State of Florida.
