

ARTICLES OF INCORPORATION  
OF

The undersigned, for the purposes of foregoing a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I  
Corporate Name and Address

The name of the corporation is Powerline Studio's , Inc.  
located at 4100 N. Powerline Rd U-5 Pompano Beach, Fl 33073.

ARTICLE II  
Term of Existence

The duration of the corporation is perpetual, to be commenced with the filing of these articles of incorporation with the Department of State of the State of Florida.

ARTICLE III  
Nature of Corporate Business

The general purpose for which the corporation is organized is  
1. to engage in a recording studio business and to do that which is incidental to the foregoing, or necessary, or desireable in order to accomplish the foregoing; and






