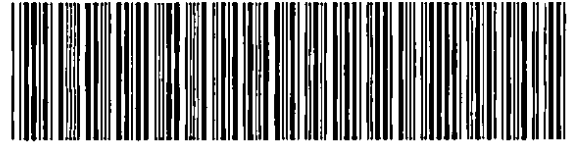

Pursuant to the provisions of Chapter 607, Florida Statutes, as amended, the undersigned Florida corporation, Merritt Speech & Learning, Inc., adopts the following Amended and Restated Articles of Incorporation. This Corporation's Articles of Incorporation were filed on March 7, 1997; Document Number P97000021113.

ARTICLE I - NAME

The name of this corporation is as follows:

Merritt Speech & Learning, Inc.

(hereinafter referred to as the "Corporation")

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - DURATION

This Corporation commenced its corporate existence on March 7, 1997. This Corporation shall exist perpetually.

ARTICLE IV - PURPOSE

This Corporation is organized for the following purposes:

(a) **To provide Speech-Language Pathologist services and Vision Therapist services; including diagnosis and treatment of processing disorders that cause developmental delays in speech, language and learning; and**

(b) The transaction of any and all other lawful business for which corporations may be incorporated, including but not limited to those powers enumerated in Section **607.0302**, Florida Statutes, et sequitur, as amended, and the doing of all lawful things related thereto.

ARTICLE V - CAPITAL STOCK

This Corporation is authorized to issue ten thousand (10,000) shares with a par value of One and NO/100 Dollars (\$1.00) per share. Each outstanding share, regardless of class, shall be entitled to one (1) vote on each matter submitted to a

vote at a meeting of the Shareholders, unless otherwise designated as "NONVOTING" by a resolution recorded in the Corporate Minute Book and a similar legend on the subject certificate(s). The shares of stock may be issued for such consideration as determined from time to time by the Board of Directors. Said consideration is to be paid in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.

Any and all powers and duties conferred to or imposed upon the Board of Directors, shall be by a resolution of the Shareholders

and/or contained within the duly adopted Bylaws of the Corporation.




