ARTICLES OF INCORPORATION

B & L NURSERY & LANDSCAPING, INC. TALLAHASSEE, FLORIDA

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is B & L NURSERY & LANDSCAPING, INC.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The general nature of the business to be transacted by this corporation is:

- a. To engage in any commercial and industrial enterprise desired to be profitable to this corporation and in conformity with the laws of the State of Florida and of the United States.
- b. To purchase, acquire, hold, sell, exchange, raise, propagate, cultivate, or otherwise deal with or dispose of plants, trees, shrubs, turf grasses, and other nursery products, both wholesale and retail; and to engage in and conduct the business of landscaping and landscaping planning and design on commercial, industrial and residential buildings and real property of all types, and of making, performing, and discharging contracts therefor or relating thereto as contractor or subcontractor, and all allied or interdependent lines of business.

FOURTH: Authorized Shares.
