ARTICLES OF INCORPORATION
OF
J.K.I. DEVELOPMENT, INC.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation shall be: J.K.I. DEVELOPMENT, INC.

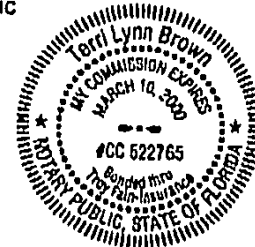
