Articles of Incorporation

of

Rausil Carpentry Corp.

I the undersigned, subscriber of these Articles of Incorporation, a natural person, competent to contract, and desiring to form a corporation under the laws of the state of Florida hereby certify as follows:

Article One

The name of the corporation shall be Rausil Carpentry Corp.

Article Two

The corporation will engage in any activity or business permitted under the State of Florida and of the United States of America.

Article Three

The maximum number of shares which the Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock, which shares will be of no par value.

All stock is to be issued as fully paid and exempt from assessment.

Article Four

The pledge, sale, transfer or other disposition of the capital stock may be governed and restricted by the by-laws or written agreement among the stockholders which shall be on file in the office of the Corporation.

Article Five

The amount of the capital with which this corporation may begin doing business shall be no less than FIVE HUNDRED DOLLARS AND NO/100 (500.00).

Article Six

The existence of the Corporation is perpetual.

Article Seven

The initial post office address of the principal office of the Corporation in the State of Florida is 1612 NW 18th Street rear, Miami Florida 33125. The Board of Directors may from time to time move the principal office to any other address in the State of Florida. The registered address of the Corporation is 1612 NW 18th Street rear, Miami Florida, 33125. The Registered Agent at the registered address is Silvia E. Gutierrez.

Article Eight

The business of the Corporation shall be managed by a Board of Directors consisting of not less than one or more than five directors. A quorum for the holding of a meeting which shall consist of a majority of the

members thereof: but the Directors by unanimous consent in writing shall have the same force and effect as though a formal meeting had been held pursuant to call being duly made as though the said act had been done and authorized at a meeting at which a quorum had been present, or such duties may be delegated to an Executive Committee.



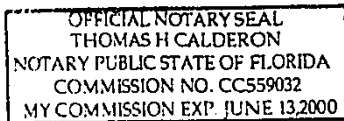
