The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: **PHYLLIS E. DOUCETTE, P.A.**, and its initial mailing address shall be: P.O. Box 2072, Palmetto, Florida 34221. The initial address of the Corporation's principal office shall be: 20506 69th Avenue East, Bradenton, Florida 34202.

ARTICLE II

The purpose of this Corporation is, within the State of Florida, to engage in the practice of, and render professional services as, a real estate salesperson as defined in Chapter 475, Florida Statutes, as amended from time to time, and to take all actions that are necessary or proper in connection with that practice.

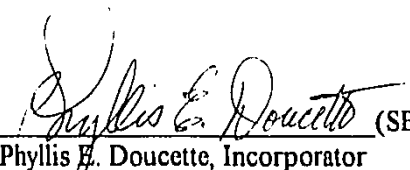

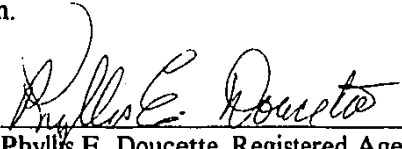
These Articles of Incorporation may be amended in the manner provided by law.
